- **Pre-Plant Soil Maintenance:** Broadcast per acre 10 to 50 pounds Organic 5r – Soil Boost EA one to two times annually
- **Planting:** In-furrow or banded per acre 8 to 10 pounds Organic 5r – Soil Boost EA one to two times annually
- **Emergence:** Broadcast per acre 30 pounds Organic 5r – Soil Boost EA
- **Growth:** Broadcast per acre 20 to 30 pounds Organic 5r – Soil Boost EA
- **Post-Harvest Soil Maintenance:** Broadcast per acre 50 pounds Organic 5r – Soil Boost EA
